Eligibility:

Lead Rein: Players 12 years and under on ponies under 138cm, accompanied by an appropriate lead rein handler (over 16 years old). The class will only run on Sunday 11th August.

Brookes Mini Championship: Players 12 years and under and horses 138cm and under. Sections of 3 players who have not attained their 13th birthday by 1st January in the current year.

Stoneleigh Junior Championship: Players 15 years and under, horses any height. Sections of 3 players who have not attained their 16th birthday by 1st January in the current year.

Charles Mason Senior Championship: Horses 138cm and over. Open Sections of 3 players of any age.

Entry Information:

All entries should be made online using <u>www.horse-events.co.uk</u>.

All entries are subject to a non-refundable booking fee as stated online.

This is a single booking form process, and entries will not be confirmed without payment.

For Pony Club entries you will need your membership number and the name of your Branch/Centre.

Late entries may be accepted at the organiser's discretion. There is a late entry surcharge of $\pounds 5$.

Entry/Competition Conditions:

To be run under Pony Club Polocrosse rules 2024.

In the event of sufficient entries and entered teams consisting of a range of abilities then the classes can be split into Novice, Intermediate and Open levels. Branches, Centres and Areas can request to be entered in a particular level. The organiser has the final say as to which sections enter each level, based on each section's respective grading.

Please ensure the competitor complies with eligibility, dress, and saddlery requirements.

A valid passport and vaccination record must accompany the horse/pony to this event and must be available for inspection if required by event officials. Vaccinations must be in accordance with the <u>Pony Club Vaccination Rule</u>.

Queries may only be raised via the event organiser by the DC/Centre Proprietor or their appointee. Protests/objections will be managed as per the PC Polocrosse Rulebook 2024.

Substitutions:

Substitutions can be made before the closing date of the event by logging in to your Horse-Events account and editing your booking under the "My Booking" tab.

Withdrawals & Refunds:

WITHDRAWALS (ALL COMPETITIONS & CHAMPIONSHIPS)

If a Branch or Centre withdraws a team or individual prior to the closing date for a competition, a full refund of entry and stabling fees will be made, less an administration charge. Withdrawals after the closing date for a competition will not be refunded.

ABANDONMENT (ALL COMPETITIONS & CHAMPIONSHIPS)

In the event of a competition being abandoned, for whatever reason, a refund of 50% of the entry fee will be given. In such an instance the refund process will be communicated and must be followed.
